Position overview

The Bendigo Water Reclamation Plant (Bendigo WRP) has been treating the wastewater from sinks, toilets and drains across Bendigo for 100 years. Funded by the customers it serves, it remains a critical piece of infrastructure for our community's health and supports our continued growth and success. But climate change, ageing infrastructure and a growing population mean we are acting now to ensure our sewerage infrastructure can meet community needs for the next 50 years.

The vision for the Bendigo WRP program is to deliver integrated, sustainable, reliable and future proofed wastewater treatment infrastructure for Bendigo and surround towns. With phase one (biosolids) of the program underway, phase two (liquids) will see a further multimillion dollar investment into uplifting the remaining infrastructure at the Epsom facility and to help future proof the site for generations to come.

Early 2025 has seen phase 2 of the upgrades at the Bendigo WRP complete a concept design and commence a High Value, High Risk business Case. The Lead Project Manager will play an integral role in all aspects of continuing the development and delivering of the project, including:

- Leading the project team, including internal and external resources.
- Managing development of project, including delivery of the business case
- Ensuring internal and external project approvals, timeline and deadlines are achieved.
- Providing oversight of gaining the required Victorian Government approvals for the project to succeed.
- Leading the required procurement for the project through to contract award.
- Accountable for the development of a Stakeholder, Communications and Engagement Plan tailored for the project.
- Managing relationships with clients and stakeholders
- Identifying and mitigating project risks
- Responsible for project reporting (internal and external)

This role is suited to someone that has strong experience in managing large construction projects (preferably across wastewater), along with demonstrated leadership and management skills. The successful candidate will be driven with strong communication skills, problem solving and technical knowledge.

Key result areas

The Lead Project Manager is accountable for the following key result areas in leading the delivery of phase two (liquids) of the Bendigo WRP upgrades.

Project & Construction Management

- Accountable for project development and delivery through internal/external approvals, procurement, tender, award, design, construction and commissioning.
- Accountable for development of the required Victorian Government Business Case approvals, in line with DTF High Value High Risk Frameworks.
- Project management to meet project milestones, including internal and external project approvals.
- Facilitating technical review of design development to meet the required project outcomes for Coliban Water.
- Financial management of budgets and forecasts to ensure the project is delivered within the allocated budget.
- Ensuring compliance with Coliban Water's Integrated Quality System and Project Management Office standards.
- Regular and ongoing project performance reporting such as EPMO updates, OH&S and Environmental audit outcomes and other project related reports that may be required.

Contract Administration and Delivery

- Management of the project delivery approach, including packaging and contract framework.
- Leading all phases of the procurement process, including tender review and negotiation for award.
- Management of the Design and Construct contract/s (or alternative delivery models) for delivery of phase two of the Bendigo WRP upgrades.
- Resolving any contractual claims arising from contractor or consultants throughout the project.
- Delivering on Coliban Water's sustainability and procurement goals, including Local Jobs First (LJF), Social Procurement Framework (SPF), Building Equality Policy (BEP) and Fair Jobs Code (FJC).

Leadership / team management

- Safety leadership for the project team, consultants and contractors.
- Effectively lead a team to deliver the project by coordinating the work of a range of internal and external resources, including technical specialists, consultancies and contractors.
- Building of knowledge, experience and capability within the project team, and encourage direct reports to act and apply good judgement.
- Setting priorities for staff to ensure the project meets the agreed programs, and professional engineering standards and ethics are maintained to ensure quality outcomes for the Coliban Water.
- Provide leadership in 'Owning the risks' across Assets and Operations department to make decisions that drive positive organisational outcomes.
- Drive operational excellence by maintaining a focus on safety, high performance and continuous improvement whilst driving performance with clarity, communication and coaching.
- Identify, lead and support change to improve organisational performance, encouraging those that challenge the status quo while ensuring a focus on proactive solutions.
- Proactively work to develop group morale and individual well-being.

Interface / stakeholder management

- Develop and maintain strong relationships with key stakeholders.
- Coordinate regular progress updates for the Project Steering Group (PSG) and other Governance groups.
- Demonstrate highly developed problem solving, critical thinking, negotiation and facilitation skills with stakeholders to achieve outcomes.
- Successfully manage project interfaces, including other projects and operations at the Bendigo WRP.
- Integration of the project and new assets into Coliban systems and networks.

Risk management

- Ownership of the risk management plan for the project.
- Develop and own a risk management plan to monitor and control the risks that have been identified and undertake regular reviews.

- Responsible for developing and implementing recommendations to manage risks related to tendering and procurement processes.
- Responsible for preparation and review of project plans to manage risks, work sequences and interfaces related to the overall project and program.
- Communicate risk information to project stakeholders.

Performance level

Action and accountability	This role provides expert advice and counsel to the business. It will be able to lead the investigation of major issues. Development of strategies to resolve problems is a key feature for this role along with a direct influence over policy / program development or delivery.
Judgement and problem solving	This role makes decisions within complex and/or dynamic environments. Problems and issues may not be easily understood and frequently arise. There is the requirement to develop new methods and/or break new ground. Advice or guidance may be limited or may not exist.
Specialist knowledge and skills	Specialist knowledge and experience in managing large construction projects (10 plus years), along with experience in the management of wastewater systems and recycled water systems, including treatment plants. Demonstrated experience in managing teams in the completion of successful projects.
Interpersonal skills	This role operates within the space of negotiation, conflict resolution and/or inspiring change. Communication has the purpose of persuading others for the matter of procedures, methods or strategies where differing opinions may exist. This role also requires the ability to lead and motivate others in the achievement of objectives (resolution of conflicts over priorities, resource use, technical concepts and management decisions).
Leadership level	Lead others: Leads, guides, and influences a team.
Qualifications and experience	 Extensive working knowledge and experience in the management of complex projects together with qualifications acquired through: A tertiary degree in Engineering, Construction Management or related field 10 plus years' experience in the field of Project Management Postgraduate qualification in project management preferred. Eligible for Chartered Professional Engineer status of the Institution of Engineers Australia or Australian Institute of Project Management
