Position overview

The Bendigo Water Reclamation Plant has been treating the wastewater from sinks, toilets and drains across Bendigo for 100 years. Funded by the customers it serves, it remains a critical piece of infrastructure for our community's health and supports our continued growth and success. But climate change, ageing infrastructure and a growing population mean we are acting now to ensure our sewerage infrastructure can meet community needs for the next 50 years.

The vision for the Bendigo Water Reclamation Plant (WRP) team is to deliver an integrated, sustainable, reliable and future proofed wastewater treatment infrastructure for the Bendigo township. Phase one of this program will see the multi million dollar upgrade of on-site facilities to better manage the final by-product of sewage treatment, biosolids.

The Lead Project Manager will play an integral role in all aspects of delivery of this project including:

- Leading the tender review and negotiation process to award a Design and Construction Contract
- Accountable for leading the detailed design review and approval process
- Leading the project team, including internal and external resources
- Ensuring projects deadlines are met
- Ensuring that the project scope is delivered within the approved project budget
- Manage commercial and program related claims arising under the delivery contract
- Managing relationships with clients and stakeholders
- Optimising and improving processes where possible or necessary
- Identify and mitigate project risks
- Manage project reporting
- Responsible for implementing Quality Assurance practices throughout delivery of the project

This role is suited to someone that has strong experience in managing large construction projects (preferably across wastewater), along with demonstrated leadership and management skills. The successful candidate will be driven with strong communication skills, problem solving and technical knowledge.
