As the Procurement Lead for the Major Projects Department, your role will be focussed and responsible for successfully driving the Procurement function, including:

- Leading end-to-end procurement processes for the Major Projects Department including being responsible for stakeholder engagement (internal & external) and the provision of direct advice, identification and management of purchasing risks, and supplier opportunities.
- Providing procurement leadership, expertise and support to the team that supports project managers throughout the project management lifecycle.
- Responsible for leading comprehensive procurement management, to ensure compliance, accountability, and optimal project performance
- Provide support and expert advice to the Executive Manager of Major Projects, Program Director and Project Managers and take the lead on providing advisory services to stakeholders.
- Engage with key program and project management personnel to provide leading practice advice, delivery and insight on their procurement needs and activities.

Procurement Delivery

- Lead and manage the development, implementation, and application of sustainable procurement strategies, technology solutions, and other practices.
- Manage end-to-end procurement, including go-to-market activities, contract preparation, execution, and financial auditing to drive commercial, environmental, and social outcomes.
- Oversee, advise, and upskill the Major Projects teams on efficient procurement processes, emphasising compliance.
- Ensure the highest ethical standards in procurement, with strong adherence to trademark behaviours, safety, and wellbeing.
- Responsible for compliance monitoring and reporting processes, including:
 - o Ownership and accountability of Procurement requirements across the Major Projects Department.
 - o Regular commercial reviews of tender documentation, development and evaluation.
 - o Identifying and reporting potential probity risks, with proposed solutions.
 - Develop and coordinate monitoring and reporting processes for all applicable procurement requirements as mandated by the Victorian Government and other relevant bodies to meet Annual Reporting requirements.
 - Develop procurement plans in collaboration with Project Managers and teams to ensure program, projects, and contractors are managed.
