Position overview

This role is part of the Assets & Operations Group and has a pivotal contribution to Coliban Water's success by being focussed on ensuring Coliban Water provides high quality customer services by efficiently and effectively managing key programs of major infrastructure investments.

The Program Manager is responsible and accountable for the delivery of a wide-ranging programs of made up of major and complex infrastructure projects in support of the Infrastructure Group's objectives. These objectives include meeting all customer and stakeholder needs whilst ensuring compliance to budget, time, safety, environmental and quality requirements including all technical and professional standards and related legislation such as Occupational Health & Safety Act.

This role contributes to the team by:

- Leading the delivery of assigned programs and ensuring they are delivered on time, on budget and to specification
- Develop of procurement strategies for effective delivery of the programs and management of the procurement processes.
- Ensuring the programs are appropriately resourced including resourcing needs to support or participate in the project teams from across the organisation
- Engagement and coordination of internal and external resources
- Ensuring programs and/or project reporting is complete in a timely and accurate manner
- Actively leading the Project Team in the delivery of projects from project inception to project handover this
 includes the early phases of a project where the project manager may be working in another team
- Undertaking project evaluations, investigations and feasibility analysis
- Preparing and/or reviewing of all documentation required and ensuring the documentation meets the required standards (i.e. regulatory, contractual, procedural etc.)
- Proactively stakeholder engagement and management
- Ensuring all project risks are identified and managed
- Facilitating lessons learned and project completion reviews and ensuring all improvement initiatives are captured and fed back through continuous improvement processes
- Ensuring that Coliban is a safe workplace and maintains a sustainable environment and meets all its statutory obligations

With an increase in investment and the ramp up in capital delivery across the Coliban Water region, this role would be well suited to someone with extensive experience in delivering large programs of work, managing large construction projects and/or long term construction works/service contracts. The successful candidate will have demonstrated leadership and management skills and possess drive, strong communication and interpersonal skills and excellent technical knowledge along with the ability to coach a team to success.
