### **Position Overview**

The vision for the Bendigo & Castlemaine Water Reclamation Plant (WRP) team is to deliver an integrated, sustainable, reliable and future proofed wastewater treatment infrastructure for Bendigo and Castlemaine townships. This program will also help to reduce operations and maintenance costs, reduce operational risk and optimise asset performance and life.

This role is accountable for:

- Building and maintaining an in-depth technical operational knowledge of allocated Coliban Water sites by regular on-site meetings and engagement with operators
- Manage operations of facilities at Bendigo WRP and Castlemaine WRP
- Management and support irrigation and farming activities
- Developing, implementing and overseeing management systems associated with sewage treatment systems (including reuse), identifying business improvements and risk management opportunities.
- Optimise, document and maintain operational decision methodologies. Contribute to the development of underlying risk factors to make consequence, likelihood, and mitigation factor tangible.
- Providing technical expertise in the areas of sewage treatment and reuse operations.
- Participation in assisting with Incident Management rosters and/or incident teams which may require participation afterhours.

# **Key Result Areas**

#### Manage process and operations of Bendigo WRP and Castlemaine WRP

- Ensure that the quality of treated water/wastewater meets the relevant obligations, standards and regulatory requirements. This includes but is not limited to the General Environmental Duties and Regulations, EPA guidelines, and customer service expectations.
- Participate in the development and implementation of compliance monitoring programs to meet obligations, inform decision making and the early identification of process issues with regards to wastewater effluent discharge and/or reuse quality and other investigative monitoring programs as required, via external and internal laboratory analysis.
- Provide technical advice on wastewater treatment and reuse issues to relevant stakeholders.
- Organise and manage maintenance works on this site

#### Manage reuse operation and farming operations at Bendigo WRP

• Gain in-depth knowledge of irrigation and farming activities on-site

- Organise and manage maintenance works at the farm and irrigation network.
- Install, calibrate, commissioning and maintain assets to a high standard.
- Sample, monitor, analyse and adjust the various lagoon processes to ensure optimal performance during off-peak and peak seasons.
- Organise cropping, farming and land management activities to control weeds, pest and allow on-site water reuse activities.
- Perform cleaning duties to maintain the farm and irrigation network.

#### Reporting, planning and budgeting.

- Assist management with organisation reporting as required, including, but not limited to preparing the monthly
  reports for wastewater sites, preparing process performance reports for treatment plants and ensuring monthly
  performance report variances from targets are addressed and implemented.
- Develop operational, maintenance and renewal budget forecasting.
- Participate in the budgeting process and be accountable for the relevant budget areas within the positions control.
- Contribute to the capital planning and setting strategic goals for the operations.

#### Performance monitoring, risk management and optimisation

- Utilise the Asset Risk processes to identify high risk assets and mitigation within the sewage treatment plants.
- Monitor the process performance of the assets and provide technical advice on process optimisation.
- Conduct process reviews and investigations to optimise the performance of each plant and respond to process/environmental related incidents.
- Optimise and manage, where appropriate, SCADA control systems for process management and reporting.
- Apply in-depth knowledge and expertise to make recommendations for process changes, for example, to chemical dose rates, for plant optimisation and management.
- Participation in the identification, classification, investigation, resolution and reporting of related operational incidents (including sewer treatment and reuse issues).

#### Other

- Act as the operational liaison between existing plant operations and works required under the capital uplift projects underway at each plant.
- Facilitate a high level of integration between the upgrade works and existing plant operations.
- Undertake testing and commissioning activities relevant to plant and/or process upgrade projects
- Represent Coliban Water in negotiations and discussions with consultants, contractors and other agencies within the limits of authority of this position and as part of the Big Water build

Action and accountability	This role is required to provide sound advice and recommendations. Advice is provided through drawing on policies, procedures, processes, and professional standards. The position is specialised in its field and supervision provides guidance and support only when needed.
Judgement and problem solving	This role makes decisions through considering a variety of alternatives. Considerations may include established management systems, standards, budget parameters and equipment. Problem resolution is a feature of this role and will require conceptualisation, development of ideas, detailed analysis and development of action plans.
Specialist knowledge and skills	Technical skills and knowledge of wastewater treatment, reuse, operations and management.
Interpersonal skills	The role requires the ability to obtain cooperation or assistance in the achievement of objectives. It will also provide information and advice to internal and/or external stakeholders.
Leadership level	Lead others: Leads, guides, and influences a team.

Qualifications and experience	Through working knowledge and experience wastewater treatment, reuse, operations and management.
